

# GENERAL PRODUCT SAFETY

## GENERAL SAFETY OF PLASTIC, METAL AND MIXED PRODUCTS

Our products do not need product certification, as they meet the definition of Italian Legislative Decree 115 of 17.03.95.

Based on such decree, a safe product is a product that during normal or reasonably predictable use, including in terms of duration, does not pose any hazards or only minimum hazards, compatible with the use of the product itself.

The items listed, produced by **TTS CLEANING S.R.L.** are not within the scope of any European Product Directives. In specific, they are not within the scope of the 93/37/EC Machine Directive, the 73/23/EC Low Voltage Directive and the 89/336/EC Electromagnetic Compatibility Directive.

Also, no specific risks connected with the cleaning items or systems of relevance have been identified.

None of the materials used are sources of chemical hazards for the users health.

The company constantly monitors the materials used, keeping their safety data sheets on file.

As far as safety is concerned, it must be pointed out that the product may not be used by non-professional users, or on non-level surfaces with slopes exceeding 1%.

It is also recommended that the items are stored away from the reach of children.

Lastly, the company shall not be held responsible for any damage caused by the substances used by operators.

## SAFETY OF ELECTRIC ITEMS AND MOTOR-DRIVEN TROLLEYS

Our electric items - Aura range - meet the 89/336/EEC Electromagnetic Compatibility Directive and are all CE marked.

Our motorized trolleys meet the essential safety requirements of Attached I of the 2006/42/EC Machine Directive, the requirements of the 2014/35/EU Low Voltage Directive and of the 89/336/EEC Electromagnetic Compatibility Directive.

Also as far as motorized trolleys:

- The **RISK** assessment has been completed in compliance with UNI EN 12100:2010.
- The **MECHANICAL** hazard assessment has been completed in compliance with UNI EN ISO 14120.
- The **ELECTRICAL** hazard assessment has been completed in compliance with IEC 60204.

Before using electric items and motorized trolleys, the operator must read the instruction booklet, which must be strictly followed. For any doubts, the operator can refer to the Manufacturer or the available Support Centres.

The materials used for the manufacturing of electric items and motorized trolleys are all materials that do not pose any chemical hazards for the health of users. The company constantly monitors the materials used, keeping their safety data sheets on file.

However, the batteries of motorized trolleys must be treated in compliance with the instruction booklet provisions and instructions for their conservation and replacement.

Motorized trolleys must only be used for transporting cleaning materials and items, laundry and similar, and always by qualified professional operators, meaning operators trained by the employer on their use and the risks that such use may entail. All the provisions of the instruction booklet must be followed during use. It is also recommended that the items are stored away from the reach of children.

Lastly, the manufacturer shall not be held responsible for any damage caused by the use of the electric items and the motorized trolleys produced by the operator.
